A s you may have noticed, construction work commenced at the intersection of W. Charleston Blvd. and Sky Vista Dr. on July 28, 2025. This work is in coordination with Tand Inc. and the Clark County Department of Public Works to convert this area into a fully signalized traffic intersection. In the interest of safety and managing expectations, please review the following information:

- **Sky Vista Traffic** For safety reasons, the Sky Vista traffic will be closed entirely to traffic for a ninety (90) day period beginning July 28, 2025.
- Community Access Impact Access from your community onto Charleston Blvd from Sky Vista will be closed for several months.
- Charleston Blvd Traffic Traffic on Charleston will remain open with flaggers managing traffic during working hours. Please drive at the appropriate speed and use caution when approaching the flaggers.

The first scholar is **Ty Yamachika**, a top five percent graduate of Palo Verde High School, who will attend University of Southern California to major in Global Health at the Keck School of Medicine before he plans to go onto medical school. Yamachika's interest in medicine was sparked by his grandfather's battle with cancer and an internship with Dr. Alan Ozaki. He has also accumulated more than 165 hours as a volunteer in the emergency room at Summerlin Hospital Medical Center.

McKenna Jost, also a recent graduate of Palo Verde High School, will attend Wellesley College in the fall to study economics and political science. She hopes to one day use her skills as a lawyer to address community injustices, including homelessness, literacy, and social mobility with the goal of strengthening local policies and legislation to improve quality of life for vulnerable populations. Jost graduated in the top two percent of her class at Palo Verde High School.

Joseph Sparks, also a graduate of Palo Verde High School, will attend the University of Nevada Reno in the fall to pursue a degree in secondary English education. Inspired by his father who taught high school English before staying home with the family while his mother practiced family medicine, Sparks has served as a volunteer at a local library, teaching children how to play chess and providing them with the basics of robotics. He graduates in the top five percent of his high school class and hopes to one day create customized learning programs for his future students.

Roxy Jones, valedictorian of Ed W. Clark High School and a graduate of its Academy of Math, Science and Applied Technology (AMSAT) program, will attend Yale University in the fall to study pre-medicine with the goal of becoming a neurologist. While excelling in school, Jones simultaneously worked two to three jobs, competed on the school's Science Olympiad team, and played piano with the school orchestra.

Follow The Fall Watering Schedule **To Save Water And Money**

any things signal the arrival of fall—football's back, **V ⊥** there's pumpkin spice on just about everything, and we're breaking out our warmer clothes. Fall also is a perfect time of year to save water by following the community's mandatory fall watering restrictions.

In effect from September 1 through October 31, the seasonal watering restrictions limit landscape irrigation to three assigned days per week. You can find your assigned watering days at snwa.com.

Watering outside of your assigned watering days can result in costly water-waste fines, and spray watering is prohibited on Sunday all year long.

To further boost conservation this fall and help manage your monthly bill, water plants and trees on a recommended two-day-a-week schedule, but for longer durations based on the flow rate of your emitters. Grass should be watered **ONLY** three days a week. While this may not sound like much, keep in mind that temperatures are getting cooler,



meaning your landscape can stay vibrant and healthy throughout the season with even less water than you think. Remember: Drip It, Don't Drown It!

If you have a grass landscape, be sure to continue running your spray irrigation systems during the early morning hours through October to help minimize water lost to evaporation, and avoid watering on windy or rainy days. And be sure to inspect and test your system on a regular basis to prevent overspray onto sidewalks and streets, which could result in a water-waste fee.
