- ☐ **LANDSCAPE (FRONT, REAR, and SIDE YARD)** – Provide landscape plan or hand drawn sketch. Identify all new plant and tree types/size, ground cover materials, and landscape to remain. A recent photo of your house must be provided with front yard landscape submittals. For artificial turf installations, please include the manufacturer specifications (i.e. turf weights, pile height). A turf sample is NOT required.
- ☐ **POOL/SPAS** – Provide pool site plan to include construction access and equipment location
- ☐ **EXTERIOR PAINT** – Identify your paint scheme selection and color designations. Provide a recent photo of your house. *(Keep in mind that color scheme may only be selected from the designated color palette for your community. Scheme selection must differ from the color schemes of adjacent or properties directly across the street.)*
- ☐ **ACCESSORY STRUCTURES (CASITA, SHED)** – Provide site plan and elevation to include setback distance to property line walls, color, material and measurements
- ☐ **ROOM ADDITION** – Provide site plan and elevation to include setback distance to property line walls, color, material and measurements
- ☐ **PATIO COVERS** – Provide site plan with setback distance, color, material and measurements
- ☐ **SOLAR PANELS** – Provide aerial view/roof plan (identify all equipment location) and panel specifications
- ☐ **WALL MODIFICATION** – For shared property line/wall improvements, a completed and signed Shared Wall Consent Form is required.
