Working To Improve Communication

During the first few decades of development in Summerlin, the approach to addressing our basic cellular coverage needs has been to encourage and accommodate an organic “individual carrier” infrastructure of antennas. Multiple carriers currently utilize any number of vertical locations throughout Summerlin ranging from library, church, school, retail and commercial building roofs to sport field lighting poles, public street light poles and occasional dedicated cell towers. The current results to this organic approach have proven to be sporadic at best. Over the past several years, our individual reliance on wireless

communication has grown exponentially, while the “individual carrier antenna infill” approach has become less timely and more challenged.

Couple these two ever-present realities with the seemingly overnight demands of all of our homes becoming temporary schoolrooms and/or personal offices and all of us quickly realize and understand how vital it is to our daily well-being that our community’s short and long-term communication highway provides us with the same organized and timely travel lanes as our community street system.

With all this in mind, The Howard Hughes Corporation has been working

with communication providers in an effort to identify and strategically locate multiple communication towers targeted to improve service within Summerlin. You may have already noticed; the first two towers were recently placed, one adjacent to the new Metro Police Station in Summerlin West, and the second next to RC Willey in Summerlin South. These new facilities should “go live” within the next few months.

The next generation of towers will be of a different height and design and planned for placement within existing and forthcoming regional park and streetscape locations to help

address coverage demands with the minimum number of tower sites deemed necessary. Currently those parks identified are Spotted Leaf, Community, Vistas, Stonebridge and Cottonwood Canyon. In addition, the far west area of Summerlin has a tower planned for the west side of Sky Vista Drive between Far Hills and Alta. As each of these facilities “goes live” over the next several months, you will most assuredly notice an improvement in our communication highway.

It is also important to note that continued utilization of other building and streetlight vertical sites throughout the community will still be necessary to work in support of these occasional towers. With the growing demand for service, the lower antenna locations will continue to serve as a critical “understory” to the overall communication system.

Thank you for your continued patience and understanding. Those of you who live in general proximity to the proposed tower locations will at some point soon be receiving notice from your respective city/county planning departments. In addition, renderings of the forthcoming towers will soon be on display at respective Summerlin Council community centers. GNMAWYA 🌻

BARKING DOGS

Dogs can be both an enjoyment and a nuisance, but dog barking is one of our most frequently received complaints. To remedy this situation, we recommend you first communicate with the pet owner in a friendly, non-threatening way. If talking it out does not solve your problem, you may contact the City of Las Vegas **Animal Control at 229-6444**. They will respond by sending a representative out who will attempt to notify the owner that a complaint has been registered and try to substantiate the complaint. If the owner is not at home, the representative will post a notice. After the third (3rd) complaint is received by Animal Control, the complaining party is requested to fill out and sign a verification form. At that time another neighbor/witness will be sought to substantiate the problem. If Animal Control receives sufficient information from the verification forms, the information is then forwarded to the city attorney for action.

After you have notified Animal Control, contact your

Summerlin Community Service Representative through www.summerlink.com. The Association will send the owner a letter about the issue. (Please be reminded that all complaints must be in writing). If the problem continues, the *Compliance Process* as outlined in previous publications is followed. This could include a hearing and a fine if the Association is able to verify the barking from at least two neighbors.

Hopefully, pet owners are becoming more aware that while doggy doors are convenient for themselves and their pets, they can create problems for their neighbors. As a courtesy to the neighbors, pet owners should not allow their pets free door access when they are not at home.

Regardless of how well behaved a dog is, it is a City Ordinance that no person owning or having possession of any animal shall cause, permit or allow the animal to stray, run or in any manner be at large. Animals must be restrained at all times so that said animal cannot leave or escape from the premises upon which it resides. Please contact Animal Control when you see dogs unrestrained, then notify your Summerlin Community Service Representative.

Working and communicating together as neighbors in a friendly manner will go a long way in controlling this issue. ☀

Being Responsible #Lockitup

As restrictions to the Covid-19 pandemic loosen, more people are returning to work and resuming normal life-styles activities. With that in mind, now is an important time to remember some important safety tips. One of the “silver-linings” of the pandemic has been a valley-wide decrease in overall property crimes. With residents staying home and not using their vehicles as much, reported auto burglaries decreased. Unfortunately, several break-ins involved criminals stealing guns left unattended and unsecured in vehicles.

The Summerlin Area Command acknowledges that owning a firearm is your constitutional right, but one that comes with many responsibilities. Ensuring you follow the legal requirements (i.e. open carry vs. Concealed Carry Permit requirement), the proper selection and training with your desired firearm is essential. Perhaps the most important factor is the proper storage of firearms when not in the possession of the owner. Many do not consider

this aspect of responsible gun ownership until it's too late.

Leaving a firearm unsecured in a vehicle creates opportunities for criminals to get their hands on a deadly weapon. A weapon that can be used to commit more violent crimes putting our children, public safety officials, and other law-abiding residents at risk. Stolen firearms have been used in robberies, aggravated assaults, and other violent crimes throughout Las Vegas. Stolen firearms have also been recovered from auto burglars caught in the act by our officers.

One best practice is preparing in advance to know if your destination allows firearms inside their establishment. If they don't, take necessary precautions to store your firearm at home or other measures to safeguard it.
