2023 Projected Budget Forecasts

For the past several weeks your respective community management teams, finance committees, and boards have been working on 2023 operating budgets. As of this writing some of your boards have not quite finalized their numbers, however here is a quick glimpse of how next year appears to be shaping up.

Summerlin North – The North currently projects 2023 revenues and expenses of \$13,083,855. This would be accomplished by increasing the present monthly assessment rate to \$60 per unit starting January 1, 2023.

Summerlin South – The South is pro-

jecting 2023 revenues and expenses of \$9,555,561. This would be accomplished by increasing the present monthly assessment rate to \$57 per unit starting January 1, 2023.

Summerlin West – The West anticipates revenues and expenses of \$9,204,740 in 2023. This will be accomplished by maintaining the present monthly assessment rate of \$55 per unit.

Summerlin Council – The Council anticipates spending \$15,280,930 next year for community park and recreation operations. To accomplish this, the Council's projected monthly share

of your master association assessment will increase \$1 to \$26 per unit. It is important to note the \$26 per month allocation is included in your respective monthly association assessments.

As a reminder, Council dollars focus on community center and pool operations, programming, special events and activities, maintenance and preservation of general park conditions, and any necessary park renovations or repairs.

This year's Council increase is primarily due to added personnel, growing labor and utility costs and targeted special turf projects. The North and South master associations would also be increasing their assessments primarily in response to increased labor and utility costs, as well as anticipated costs to mandated turf reduction projects designed to address relentless drought conditions.

Please note that more specific budget information is mailed to each of you by your respective associations as part of your annual budget ratification process.

My thanks to the many individuals that volunteered their time to work on next year's numbers. It is my sense that each of these budgets achieves the overall goal of preserving the operations and appearance of our Summerlin community in the most value-conscious way possible.

How Safe is Your Safe?

When it comes to safes, there are so many options that it can be overwhelming. There are various pros and cons with every kind of safe on the market so it's important to be educated on what you already have or are planning to purchase in the future.

What type of safe are you looking for? Wall safes can seem secure, but they can also be cut out of the wall and stolen entirely. People may think they're very clever, but burglars know where to look for wall safes so be careful when storing things in there. There are also floor safes which are very difficult for burglars to attack but usually offer little in fire protection. There are many free-standing safes that can come with the best of both worlds in terms of fire and burglary protection but must be bolted down to prevent a burglar from just taking the safe with them.

Safes should be placed somewhere with adequate lighting so you can see the combination and somewhere you're



comfortable with accessing. If you're getting frustrated with your safe, you won't end up using it and it will likely be a waste of money. Keeping the safe "out of sight out of mind" is usually the best practice. Places like a guest bedroom closet or utility room are good places to store your safe.

Check the burglary rating on your safe. If you're thinking of storing things that cost \$10,000+, you might want to consider getting a higher rated safe. You can read up online on what each of the classifications means. If you're planning on storing expensive property, you should look into the higher rated safes on the market. ☀

LANDSCAPING REQUIREMENTS SUMMERLIN WEST



Have you recently moved to Summerlin West? Are planning on making any modifications to your home? Please note some helpful reminders of requirements under our governing documents prior to making any modifications to the exterior of your home.

Section 1.15 of the Supplemental Declaration of Covenants, Conditions, Restrictions and Reservation of Easements reads in part as follows: "Rear yards shall be substantially complete within one year following the date of conveyance of the Lot from the Participating Builder to the first owner other than a Participating Builder." This means that if you purchased your home directly from the builder you have one year from the date of the close of escrow to have your rear yard substantially completed. If you are a second or subsequent owner of your home, you have one year from the date the first owner closed escrow from the builder (see previous sentence). The Association will approve two inches of decorative landscape rock covering all areas of bare dirt as "substantial completion" of a rear yard.

Section 1.12 of this same document continues as follows: "There shall be no excavation, construction, alteration or erection of any Improvement (including any projection) which in any way alters the exterior appearance of any existing Improvement or any portion of a Lot without the prior approval of the Design Review Committee."

Plans must be submitted to the Design Review Committee for any modification being made to the exterior of your home, prior to any work being performed.

The requirement for submittal also extends to rear yard landscaping whether it is to be homeowner or builder installed. So, if you are approaching your one-year time requirement for rear yard landscaping, please be reminded that your rear yard landscape plans also must be submitted to the Committee for review prior to installation. If you installed your rear yard landscaping without first obtaining approval from the Design Review Committee, you should submit those plans as soon as possible for consideration. The Improvement Request Form is available at 2115 Festival Plaza Drive, Suite 220, Las Vegas, NV 89135 or at summerlink.com. The Design Guidelines and Standards are also available online. Please be reminded that the governing documents provide for a 30-day review process starting on the date that a complete submittal (all required information needed for the review) is received by the Association. ☀
