# SUPPLEMENTAL DECLARATION OF ADDITION OF LAND SUBJECT TO ANNEXATION

This SUPPLEMENTAL DECLARATION OF ADDITION OF LAND TO ANNEXABLE AREA ("Supplemental Declaration") is made on February 20, 2014 by HOWARD HUGHES PROPERTIES, INC., a Nevada corporation ("Declarent"), and the SUMMERLIN SOUTH COMMUNITY ASSOCIATION, a Nevada non-profit corporation (the "Association"), with reference to the following facts:

#### RECITALS

- A. On December 31, 1991, the Master Declaration of Covenants, Conditions, Restrictions and Reservation of Easements for Summerlin South Community Association was Recorded by Howard Hughes Properties, Limited Partnership, predecessor-in-interest to Declarant, in Book 911231 as Instrument Number 01517, as amended by that certain Amended and Restated Declaration of Covenants, Conditions and Restrictions for Summerlin South Community Association Recorded in Book 970328 as Instrument Number 01004, and as further amended by that certain Supplemental Declaration of Addition of Land to Annexable Area Recorded on February 5, 2008 in Book 20080205 as Instrument Number 03772 (as so amended, the "Master Declaration"), covering certain real property described therein as Summerlin South.
- B. The Howard Hughes Company, LLC, a Delaware limited liability company ("THHC") is the owner of the real property located in the County of Clark, State of Nevada, described on Exhibit "A" attached hereto (hereinafter the "Property").
- C. In accordance with Section 9.2 of the Master Declaration, the Association may subject additional property to the provisions of the Master Declaration upon the affirmative vote of Voting Delegates (as defined therein) representing more than 50% of the Class "A" votes of the Association.
- D. At a meeting duly called on February 18, 2014, Voting Delegates representing more than 50% of the Class "A" votes of the Association voted to approve the ennexation of the Property into the Master Declaration.

- E. Declarant desires to add the Property to the Land Subject to Annexation as described in Exhibit "B" of the Master Declaration and to provide notice to subsequent owners of the Property that it may be annexed to the Master Declaration.
- F. THHC desires to consent to the addition of the Property to the Land Subject to Annexation under the Master Declaration.

NOW, THEREFORE, Declarant hereby declares that the Property is hereby added to the Land Subject to Annexation set forth in Exhibit "B" of the Master Declaration. Upon recordation of this Notice, such Property shall be subject to annexation to the Master Declaration, pursuant to the terms of the Master Declaration, and upon such annexation, the Property shall be subject to the terms and provisions of the Master Declaration.
